Once students are aged 13 or over, we are required by law to pass on certain information to the provider of youth support services in our area. This is the local authority support service for young people aged 13 to 19 in England. We must provide the addresses of pupils and their parents (and the pupils' dates of birth) and any further information relevant to the support services' role.

However, until pupils are aged 16, their parent(s) can ask that no information beyond name, address and date of birth (and the parent's name and address) be passed on to the youth services provider. This right transfers to the pupil on their 16th birthday. Pupils should inform the Head's PA if this is what they or their parents wish.
